The International Organization for Standardization (ISO) has developed ISO 27001 Certification to ensure the data security and privacy of clients, customers, and other stakeholders.

The ISO keeps updating the provisions of various management system certifications to cope with ever-changing business needs and requirements. The ISO/IEC 27001 certification was recently updated in 2022, and the new version is known as ISO/IEC 27001:2022 certification. Annex A controls are an integral part of the ISO 27001 standard, and the latest version significantly changed 114 security controls.



Non-Conformance in the Manufacturing Industry

Quality control in Manufacturing is crucial to a product's performance and profitability. Without quality control, faulty products can drive up costs through costly rework and repairs and potentially compromise safety. There are a lot of manufacturing non-conformance that needs to be spotted, and how to deal with it.

What exactly is Non Conformity?

Any component or product that does not satisfy (or conform to) the specification is referred to as a non-conformance (or nonconformity/non-conformance).

Regulations and standards established by the industry itself may also be broken by non-conformance. In this situation, a third-party authority (like the FDA) may control the acceptable levels of various food products. For instance, the FDA might forbid the use of specific components or substances in a range of foods, dietary supplements, or medical devices. Or, they might only permit a specific quantity in the items. Before a manufacturer is permitted to sell their products on the open market, they must first submit samples for inspection and testing. Retesting is necessary, and if non-conforming goods are discovered, corrective action is needed.
