



o Develop and implement an Information Security Management System (ISMS) and a Privacy Information Management System (PIMS) in line with the standards.

o Ensure that policies, procedures, and controls are in place.

#### 3. Internal Audit:

- o Conduct an internal audit to ensure compliance with ISO 27001 and ISO 27701.
- o Identify any non-conformities and take corrective actions.

#### 4. Certification Audit:

o Engage an accredited certification body to perform the certification audit.

o Address any findings and achieve certification.


