ISO 9001 Revision Progress

The Draft International Standard (DIS) for the next version of ISO 9001 was published for public comment (until October 20, 2025), highlighting a fresh emphasis on quality culture, ethical conduct, and leadership in driving continual improvement.



● U.S. FDA Aligns with ISO 13485

The U.S. Food and Drug Administration (FDA) announced in October 2025 a final rule to align its quality system regulations with the international standard for medical device quality management systems, ISO 13485:2016.

The updated regulation will take effect in February 2026.

India Lays Down Big Bet on Research & Innovation

The India Rising Foundation announced a ₹ 1,000 crore (~US\$ 120 M+) fund to support R&D. The fund targets up to one million research fellows, across 12 key areas: medicine, deep tech, space, defense, sustainable energy, and more. A notable twist: the initiative aims to fuse “ancient wisdom” (traditional knowledge) with cutting-edge science.



2025 Nobel Prize in Chemistry

Awarded to Susumu Kitagawa, Richard Robson, and Omar Yaghi for their work on metal-organic frameworks (MOFs). MOFs are porous molecular structures with huge potential: they can trap gases (like CO₂), harvest water from air in dry regions, and remove pollutants. This has big implications for climate technology (carbon capture) and environmental sustainability.

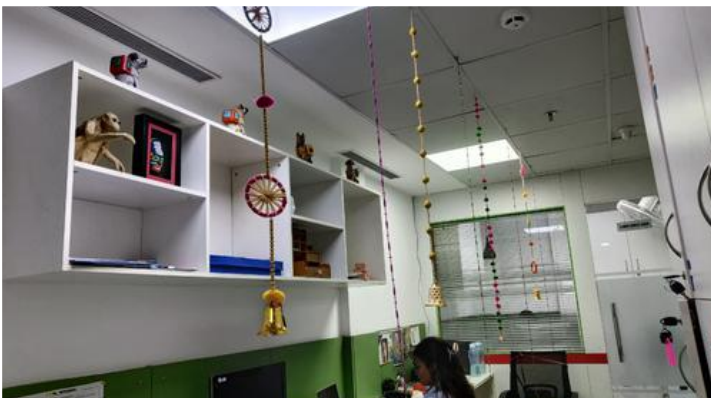
